The University of York Mumbai brings this approach to India, combining York's academic rigour with opportunities that prepare students to think independently and work collaboratively in a changing world.



Grounded in Research

York's global reputation is built on the strength of its research and how it informs teaching. At the University of York Mumbai, students are introduced to ideas and evidence that shape their fields, learning to analyse, question, and apply knowledge in context.



Guided by York and India

Teaching at the University of York Mumbai is a collaboration between academics from the home campus and India-based faculty. Members of the York community will teach and mentor in Mumbai, ensuring that the curriculum and assessment meet the same standards as in the UK.

This shared approach brings together local insight and international experience to create a connected academic environment.



Learning That Builds Understanding

Courses are structured to help students make connections across subjects and ideas. Teaching combines lectures, tutorials, discussions, and project work, encouraging students to explore, question, and develop practical understanding. Over time, students move from structured study to more independent and applied work, supported by access to York's digital learning resources and online tools.



Connected to Industry and the World

Every programme links classroom learning with real-world experience. Through guest lectures, case studies, internships, and live projects, students gain a professional perspective and practical skills. University of York Mumbai has established Indian partnerships, connecting students to industry mentors and emerging opportunities.

A dedicated Research Office in Mumbai supports joint projects between the India and UK campuses, giving students an early start in research and innovation.

Career Journey

Career development at the University of York Mumbai begins from the start of the student journey. Through Career Services, students demonstrate their skills and experience through career awareness and skill discovery, CV and LinkedIn development, mentoring, mock interviews, assessments, leadership talks, live projects, hackathons, and placement preparation.

Undergraduate Journey

First Year: Discover | Engage | Grow

Students activate their Career Services profile, begin exploring professional skills, build their CV, join clubs and committees from Week 1, explore community engagement, and complete a six-week Social Impact Internship.

Second Year: Explore | Experience | Develop

Students refine their CV and LinkedIn profile, participate in communication and workplace readiness workshops, attend leadership talks by York alumni and industry leaders, practise mock interviews, and complete an eight-week Sales and Marketing Internship.

Final Year: Apply | Focus | Launch

Students review their professional skills, develop relevant networks through York for Life, participate in mentoring and assessments, apply for graduate internships, jobs or future studies, and complete a 12-week Corporate Internship with continued support towards internship-to-PPO conversion.

Postgraduate Journey

Semester 1: Engage | Analyse | Focus

Students register with Career Services, identify strengths and development areas, complete skill-gap and role mapping with industry mentors, develop their CV and LinkedIn profile, attend career talks, participate in live projects and hackathons, and engage in mock interviews and assessments.

Semester 2: Apply | Integrate | Impact

Students develop a final CV for placements, complete a four-week York Mumbai internship, engage in final placement interviews, and receive continued Career Services support through placements, entrepreneurship, higher studies, and pre-placement opportunities.

Internship Pathways

Undergraduate Internship Pathway

Undergraduate students complete a progressive internship journey across three years: a six-week Social Impact Internship in Year 1, an eight-week Sales and Marketing Internship in Year 2, and a 12-week Corporate Internship in the final year. These experiences build social awareness, commercial confidence, workplace readiness, and stronger pathways towards graduate opportunities.

Postgraduate Internship Pathway

Postgraduate students complete a four-week York Mumbai internship in Semester 2, choosing from three pathways: SAHAJ for rural, MSME and social impact projects; SPARK for start-up and founder immersion; or YORK BRIDGE for global and corporate exposure. Each pathway helps students align practical experience with their career aspirations.

Your Journey to York, UK

Studying at the University of York Mumbai means becoming part of a global community that extends to the home campus in York, UK. Through structured mobility pathways, students have the opportunity to experience York directly and deepen their connection to the wider university.

2+1 Programme

Complete the first two years of your degree in Mumbai and your final year at the University of York, UK. Scholarships are available for eligible students transferring to the home campus.

Semester Exchange

Spend your second semester of Year 2 at the University of York, UK. Students pay Mumbai tuition for semester one and York semester fees, inclusive of scholarship.

Postgraduate

York Residency

Every University of York Mumbai MSc student has the opportunity to experience York as a campus and community. Through a structured two-week residency in the UK, comprising 10 intensive days with weekends free to explore, it delivers a credible, timetable-safe York UK experience in Year 1, with strong academic and employability value.



Student Experience, Engagement and Development (SEED)

SEED is the University of York Mumbai's student engagement framework, designed to create a holistic and vibrant student ecosystem. Through up to 15 hours of structured, voluntary non-academic engagement each week, students can build wellbeing, belonging, industry awareness, leadership, faculty interaction, and personal and professional development alongside academic learning.



Corporate Engagement

Guest lectures, mentoring, live projects, hackathons, networking sessions, and start-up interactions help build industry readiness and exposure.



Faculty Engagement

Research circles, faculty conversations, interdisciplinary discussions, innovation labs, and project mentoring extend academic mentorship beyond the classroom.



Community Engagement

NGO projects, sustainability initiatives, rural immersion, outreach, and social innovation programmes encourage responsibility and impact.



Peer Engagement

Student clubs, sports, performing arts, peer mentoring, competitions, and student-led events help shape campus culture and student leadership.

Classrooms and Labs

Teaching happens in modern, well-equipped classrooms with digital tools that support discussion, demonstrations and project work.



Library and E-Resources

Students will have access to digital libraries, course readings and online learning platforms, along with quiet and group study areas on campus. Remote access to approved York systems helps keep learning continuous, on campus and beyond.



Innovation and Research

An on-campus Research Office will connect students and faculty in Mumbai with York's wider research community. Students will benefit from opportunities to access specialist facilities in York through short academic visits as part of the Global Connections programme.



Student Living in Mumbai

Student living at the University of York Mumbai is designed to support more than accommodation. It offers a safe, well-managed environment where students can focus on their academic journey, build friendships, and feel part of a connected university community.

Ashok Deluxe Apartments

The student housing option is located at Ashok Deluxe Apartments in Marol, a well-connected neighbourhood approximately 4.1 km from the University of York Mumbai campus location at One Boulevard, with an estimated travel time of 25 minutes. The property offers apartment-style living within a secure residential complex, supported by dedicated teams for operations, dining, housekeeping, maintenance, and student support.

Amenities and Services

Students will have access to study-friendly rooms, common lounges, dining spaces, recreational areas, gymnasium facilities, indoor games, and peer engagement spaces. The accommodation experience is further supported by shuttle connectivity aligned with academic schedules, 24/7 security, access-controlled entry, CCTV coverage in common areas, laundry support, app-based helpdesk services, and meal plans designed around student wellbeing.

Selection Criteria

- The selection of undergraduate students is on the basis of their academic performance (Class X and Class XI marks), personal interview, and achievements in extracurricular activities.
- Shortlisted candidates will be invited to appear for the personal interview following a competitive evaluation of their academic record. Submission of an application does not guarantee an interview call, as only a select number of applicants will be shortlisted for this stage of the admissions process.
- For candidates with an outstanding academic record, the personal interview may be waived, and admission can be offered solely based on academic performance. Class X scores will serve as a key criterion in assessing academic merit.

Evaluation Criteria

i) Academic Performance:

The university has outlined four strategic aims, grounded in the core principles mentioned above, which will pave the way for bold and distinctive actions: curiosity-driven and action-oriented research, foster discovery, inspire teaching, and forge international partnerships while recognizing students as both recipients and drivers of new knowledge.

ii) Personal Interview:

- Shortlisted applicants will be invited for a structured personal interview conducted by a panel from the Admissions Committee.
- The interview will evaluate:
 - Communication and articulation
 - Alignment with the university's values and offerings
 - Motivation, resilience, and future aspirations

iii) Extracurricular Activities:

- Applicants are encouraged to submit documented evidence of their participation and achievements in:
 - Sports
 - Debates, quizzes, and public speaking
 - Clubs (cultural, academic, or interest-based)
 - Community service or social initiatives
 - Creative or entrepreneurial pursuits

Selection Criteria

- The selection of postgraduate students will be based on their academic performance (Undergraduate marks), personal interview, letters of references, statement of purpose and achievements in extracurricular activities.
- Candidates in their final year of Undergraduate Studies are also encouraged to apply. Merit will be assessed based on marks obtained up to the last declared semester/year of the UG programme, and final admission will be subject to submission of the complete and qualifying degree results as per the minimum eligibility criteria defined in the above section.
- Shortlisted candidates will be invited to appear for the personal interview following a competitive evaluation of their academic record and other relevant criteria. Submission of an application does not guarantee an interview call, as only a select number of applicants will be shortlisted for this stage of the admissions process.
- The University reserves the right to waive off the interview process (for programmes where applicable) for candidates possessing an exceptional score in CAT/ XAT / MAT / NMAT / GMAT / CMAT examinations.

FEES, FUNDING AND SCHOLARSHIPS

Studying at the University of York Mumbai provides access to a globally recognised UK degree at a fraction of the overall cost of studying abroad. Students enjoy the same teaching standards, faculty support, and academic rigour — now closer to home.

Domestic or International Fees?

The level of fee that you will be asked to pay depends on whether you're classed as an Indian (domestic) or international student.

Domestic Students

Domestic students are applicants who are Indian nationals and currently residing in India, applying for undergraduate or postgraduate programmes at the University of York Mumbai.

Please note: In order to be considered as a domestic student, the applicant will need to both be an Indian citizen and be residing in India at the time of application.

Eligibility & Criteria

- Must meet the minimum academic qualifications specified for the chosen program, as outlined.
- Should have completed the relevant qualifying examinations from recognized boards in India (e.g., CBSE, ICSE, State Boards).
- Must fulfil any program-specific eligibility requirements, such as subject prerequisites or minimum marks.

Application & Selection Process

- Applications are submitted through the University's official admissions portal within the prescribed deadlines.
- Domestic applicants are evaluated based on academic merit, entrance test scores (if applicable), and holistic criteria, including extracurricular achievements, personal statements, and interviews where required.
- Shortlisted candidates receive an offer letter, subject to verification of documents and fulfilment of eligibility criteria.

International Students / Foreign Nationals / OCI / PIO

International students are applicants who are Foreign Nationals; Non-Resident Indians (NRI), Overseas Citizens of India (OCI), or Persons of Indian Origin (PIO) and residing outside of India, seeking admission to undergraduate or

postgraduate programmes at the University of York Mumbai.

Eligibility & Criteria

- Must meet the minimum academic qualifications specified for the chosen program, as outlined.
- Must satisfy any program-specific eligibility requirements, such as subject prerequisites or minimum grades.
- English language proficiency must be demonstrated through recognized tests such as IELTS or TOEFL, unless exempted under the University's guidelines.

Application & Selection Process

- Applications are submitted through the University's official admissions portal within the prescribed deadlines.
- Applicants are evaluated based on academic performance, standardized test scores, personal statements, and interviews where applicable.
- Shortlisted candidates receive an offer letter subject to verification of documents and fulfilment of eligibility criteria.

Please note

- Foreign Nationals are required to possess a valid Student Visa issued by the Government of India for the duration of their study in the country.
- Domicile is the primary factor when it comes to deciding fee status, and as such, Indian nationals residing overseas at the time of their application, where the primary residence has been outside of India, will be considered as an international student.

Sustaining Your Scholarship

To continue receiving the scholarship, students are required to maintain a minimum academic score of 70% each year.

The University of York Mumbai will also offer Access Scholarships to support students who may require financial assistance to pursue their studies.

REFUND POLICY

The University of York Mumbai is committed to ensuring transparency, fairness, and student welfare in all financial matters. This Fees Refund Policy for the Academic Year 2026–27 has been framed in accordance with the University Grants Commission (UGC) Notification on Fee Refund and Non-Retention of Original Certificates (2024).

i) Application Fee

The application fee of INR 2,000 is non-refundable under any circumstances.

Applicants are advised to verify eligibility criteria, programme details, and deadlines prior to making payment.

ii) Tuition Fee

The refund of tuition upon withdrawal of admission shall be governed by the timelines specified below, as per UGC 2024 guidelines and institutional best practices.

Time of Withdrawal of Admission	Percentage of Refund of Fees
15 days or more before the formally notified last date of admission	100% (a deduction of an amount not more than 5% of the fees, subject to a maximum amount of INR 1,000/- as processing fees)
Within 15 days before the formally notified last date of admission	90%
Within 15 days after the formally notified last date of admission	80%
Between 16 to 30 days after the formally notified last date of admission	50%
After 30 days from the formally notified last date of admission	No refund



In cases where a student has been granted a scholarship or fee waiver and subsequently withdraws, the refundable amount shall be calculated after adjusting such concessions.

All eligible refunds will be processed within 15 working days from the date of receipt of a complete withdrawal application.

iii) Admission Fees

The admission fee of INR 50,000 paid by the student at the time of confirming admission shall be refundable on cancellation of admission by the student.

iv) Security Deposit

The security deposit of INR 50,000 collected at the time of admission is fully refundable at the time of graduation or upon withdrawal from the University, subject to clearance of all dues, return of university property (if applicable), and completion of exit formalities.

Mode of Refund

All refunds shall be made directly to the bank account provided by the student/parent at the time of withdrawal application. No refunds will be issued in cash.

Refunds shall be processed only after the student submits a duly signed withdrawal request along with necessary documentation.



Cost Advantage

Pursuing a York degree in Mumbai offers exceptional value, with lower tuition costs and significantly reduced living expenses. Students access the same curriculum, teaching standards, and degree recognition as York's UK Campus, while enjoying the benefits of proximity to India's opportunities.





Regulatory Assurance and Recognition

The University Grants Commission (UGC) has granted a licence for the University of York to establish a campus in Mumbai, marking a key milestone in India's higher education landscape. This approval was granted under the revised National Education Policy (NEP 2020), which opened doors for trusted global universities to establish campuses in India.

Students graduate with a globally respected University of York degree, with the same structure and academic standards as in the UK, and fully compliant with UGC requirements in India. For parents and students alike, this serves as a clear assurance of York's commitment to quality and legitimacy.
